Report of the workshop

The meeting was being held at Phnom Bros Hotel meeting room in Kampong Cham province from 20-21 September 2018. 54 Participants from BMLS, National, CPA3 & CPA2 under CamLIS (34sites), and partners (ITECH, DMDP, WHO):

- The workshop objectives and agenda was introduced by Ph. Uch Monipheap.
- Interested speech of Deputy Director of Kampong Cham Provincial Health Department,
 Prof.assistant PANG Dany about successes activities and effective works supported by information system
- Interested noted of Deputy Director of DHS about important of technology update response to IHR and regional development, and the need to motivate physician using CamLIS system due to theirs access the system are limited. He also mentioned about lab staff should look back on theirs manuals and develop SOP against specific agents. One more interesting concern, is to include national Program such as Malaria, HIV and TB (pending) and animal Health in CamLIS. In the near future, Molecular Biology that few national program and laboratories performed shall be introduce in the system too.
- Mr. LENG Vanra, IT specialist from WHO Cambodia presented interesting video of CamLIS installation.
- Via discussion among stakeholders, we got feedback from national program about the challenge inserting result of malaria and HIV into system and the solution with clean explanation from the representative of CNM and NCHADs. The updated, issue recommendation, and Future steps in CamLIS were discussed on challenges and find solutions/recommendations.
- The issues of approving and controlling lab results is the sensitive approach for difference lab level. This issue refer to each lab to decide.
- Group discussion on lab request form were conducted and final lab requested form were accepted.
- Mr. LENG Vanra, IT specialist from WHO Cambodia presented the tip to create strong password for CamLIS users. (see attached file)
- Question and answer about supply of lab reagents form CMS, Suggestion CamLIS notification
 while any update or unappropriated chosen click and bottom for easy access to manual, short
 video of using CamLIS.
- CNM will make an exam in November 2018 to obtain the specialist in Cambodia in Malaria diagnosis examination by microscope.
- CNM: will send soft copy of national guideline and SOP related to Malaria to member today by mail (please alert back)
- More site for installing CamLIS in 2019.
